1. Approval of April 8, 2024 Charter Review Minutes.

Motion Member Newton to approve the minutes of the April 8th, 2024, Charter Review Meeting Minutes. Second Member Swilley Motion carried 5-0.

2. DISCUSS POSSIBLE RECOMMENDATIONS FOR CHARTER AMENDMENTS

Chair Weller reviewed the proposed language submitted by the Attorney and asked for any edits and opinions.

Member Newton motioned to approve amended language with the addition of 'either publicly or privately directly or indirectly' to section 2.06 Motion Second Member Swilley Motion Passed 5-0

Member Newton Motioned to approve amendment to section 3.04 number 11 with the language provided. Motion Second Member Swilley Motion Passed 5-0

Member Jamison motioned to approve section 5.02 as amended. Motion Second Member Swilley Motion Passed 5-0

Member Tapia-Ruano motioned to approve changes to section 5.05 list of properties as amended. Motion Second Member Newton Motion Passed 5-0

Attorney Walker advised he had received feedback from the Supervisor of Election Kim Barton, and she advised that in order to hold a run-off election she requires 4 weeks at minimum.

Member Jamison believes that (in section 4.08) implementing a run-off election would create too great of a burden and without an accurate voter representation.

Member Newton is also concerned about the time restriction proximity of a run-off election to the Christmas holidays further affecting the voter representation.

Member Jamison Motioned to add new language as discussed in section 2.02. (The candidate running for a party seat that receives the greatest number of votes is the winner. In the event of a tie, the winner will be determined by the flip of a coin by the City Clerk on the day of the election)

Motion Second Tapia-Ruano Motion Passed 5-0

Member Jamison Motioned to strike the last sentence of section 3.01 which permits the commission to combine the offices of City Clerk and City Manager. Motion Second Member Swilley Motion Passed 5-0
