Staff Wilson gave a presentation and overview on the status of the budgets for Capital Funding Sources,

Vice Mayor Grunder expressed concerns for using ARPA funds for re-occurring expenses and would like to research and discuss this further.

Mayor Weitz discussed potential costs and changes to the WW Treatment plant and wetlands and if could funds be reallocated if needed to improve them.

The City Clerk's Budget was discussed and reviewed. The budget is slightly over-expensed due to an additional Election not planned for but was overall in good standing.

The Fire Department budget was discussed and is doing well. They have decreased personnel costs as well as limited spending where possible.

Water and Wastewater capital budgets were discussed and are currently below projected budgeted expenses. Repair and Maintenance & Grinder Pump repair line item budgets are over-budet.

Mayor Weitz asked could the boat at the fire department be sold. Staff Wilson and interim Fire Chief Vogel advised that yes it potentially could be.

Commissioner Miller questioned could the city revisit certain fees and projects to discuss.

Public comment:

Rick Testa – as a taxpayer, he would like to see the fire equipment, new paging system, and apparatus re-evaluated to see if they could be sold to lower costs.

Interim Fire Chief Vogel – explained the process and procedure for utilizing the special equipment at the fire department specifically the "heavy rescue" apparatus and how he lowered its matrix down to a "squad" rather than the heavy rescue designation that was more costly in both time and training. He advised it is a very costly apparatus and understands the citizens concerns.

City Manager Marshall – advised he would be meeting with Interim Chief Vogel to discuss a transition plan as well as how to approach planning with the new Fire Chief who will be arriving soon.
